3 60 Public Session²

3.1 Ward Cllr George Crozer spoke on behalf of Alliance of Parish Councils. He confirmed that members of the Alliance would be attending on a monthly basis to ensure that we all stand together as a Peninsula. Chair Cllr Craddy confirmed that the Council were fully aware and included in the Alliance which was most welcome.

3.2 **Ward Cllr Michael Pearce** confirmed that he had been in communication with Esquire Developer about the advertising of the new development as being situate in High Halstow when the area is quite definitely in the Parish of St Mary Hoo.

There had also been an issue with the roadworks on Fenn Street which had been a serious issue to residents.

The Local plan had been further delayed and would more than likely to be published in the Spring. A river strategy would also need to be organised which just delayed matters even further

The Local Government Review (LGR) is also in progress. The thinking was that more likely that Dartford, Gravesham, Medway and Swale would be one unitary Council – but this issue was still being considered, and the final decision would come from the Government.

Medway Council had issued a preliminary budget, and it was looking like a 5% increase. If the Government provides local councils, the go ahead to increase to up to 10% then this figure would be more likely.

- 3.3 **MOP1** spoke of her dismay at the road closure that is expected in February. She had also spoken to a representative from the Water Board who was working in the region of her home. Cllr Craddy confirmed that works are being carried out regarding water supplies.
- 3.4 **MOP2** also spoke of her disappointment of the roadworks and the work carried out regarding water.
